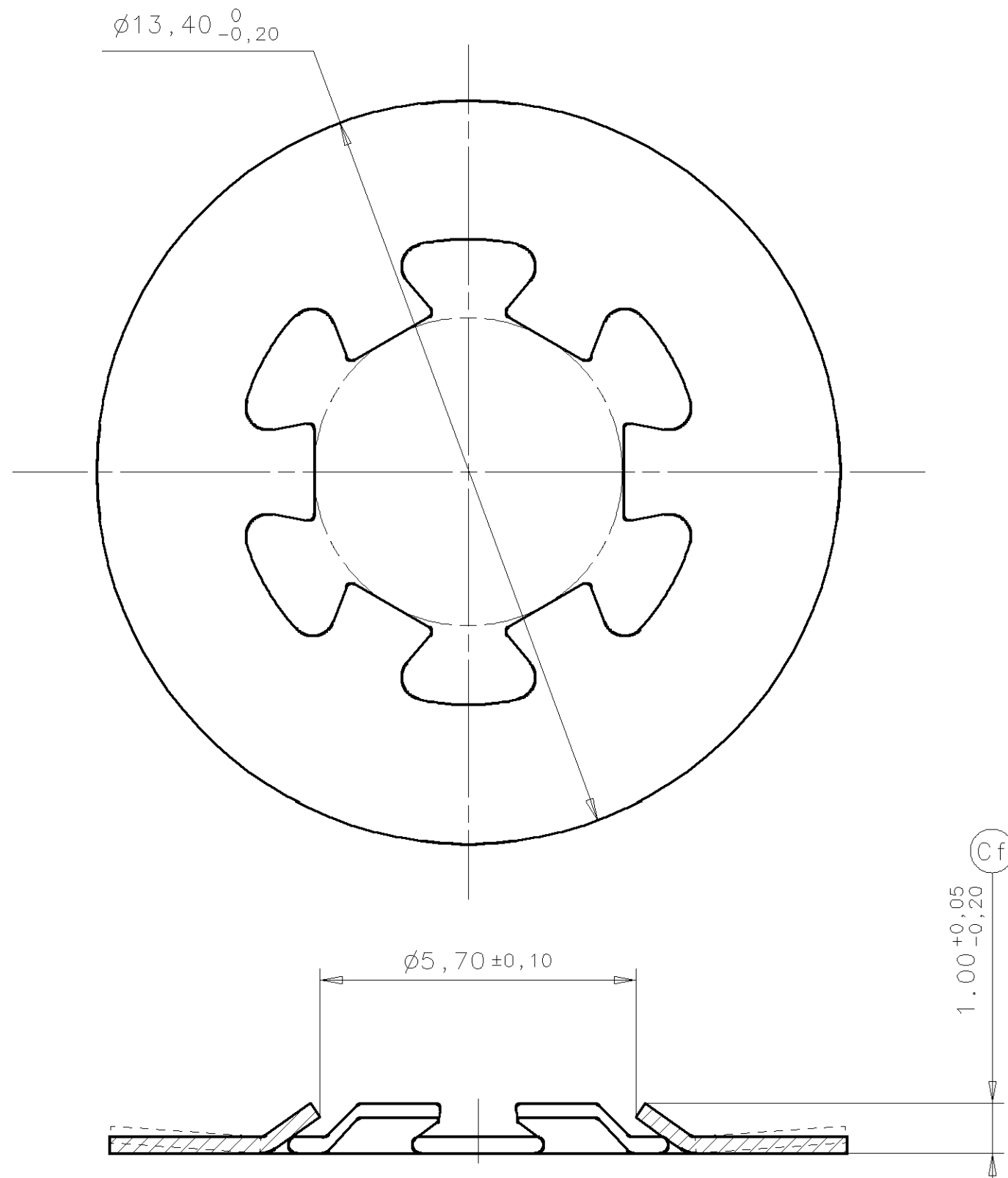
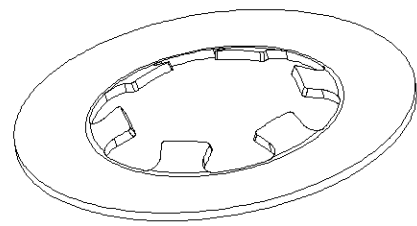

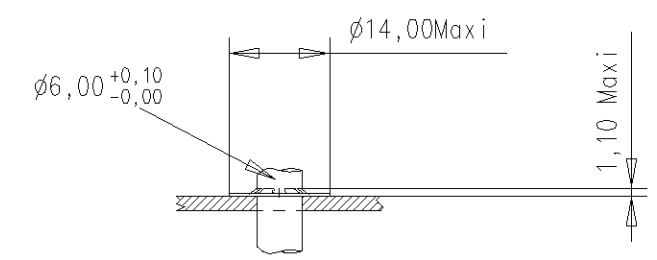


VUE 3D/3D VIEW

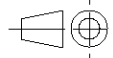
